GENERAL INFORMATION

Yamaneko-Ryu Karate Club was started by Sensei Ian Lennox (5th Dan) in Durban, KZN. It was solely a Kyokushin Karate Club, it was then passed down to Sensei Ivan Rossi who started his karate career in 1982 under the guidance of Sensei Ian Lennox. The dojo was then moved to Cape Town in 2005, and Sensei Ivan was then joined by his son Sensei Giovanni Rossi.

Sensei Ivan has over 38 years of karate experience and has attended many competitions in his career. Whilst in Cape Town Sensei Ivan was graded to 4th Dan in Kyokushin Karate by the Tezuka Kyokushinkai Association of Japan in 2014. Sensei Giovanni was also graded to 3rd Dan in 2014. Yamaneko-Ryu in 2019 decided to change direction and move over to another style and association namely United Shotokan-Ryu, the decision was chosen so that the students will be able to enter International Competitions as well as Olympic Competitions.

The club name 'Yamaneko' (山猫), is Japanese for 'wild cat'. It is referred to as someone who is strong, vicious and strikes fast. Yamaneko - Ryu focuses on traditional shotokan karate now but is also involved in the sporting side, therefore tournaments are now regularly attended.

TERMS & CONDITIONS

Sensei: Instructor

Karateka: Practitioner/student of karate

Dojo: Training facility and premises

Grading: Examination to next belt level

- 1) All karateka are subject to the rules and regulations of Yamaneko - Ryu Karate.
- 2) **Karate is a contact sport with the possibility of physical injury. Training is therefore done at own risk; however, the utmost care is taken to ensure that no karateka is being put at serious risk during the training sessions.**
- 3) Sensei Ivan or Sensei Giovanni as well as any other instructors taking the class needs to be informed of any medical conditions **BEFORE THE CLASS.**
- 4) Karateka's will not be allowed to participate in training if such training will impair their health in any way. However; every karateka **injured or not will be at all lessons** to show spirit and support fellow karateka's.
- 5) Please, no parents allowed inside the dojo while class training or grading takes place, except otherwise informed so by Sensei's.
- 6) Correct karate outfit will be worn to class, Full Karate Gi & Belt or Karate Pants, Belt & Club Shirt.
- 7) No jewellery, armbands, watches, shoes, socks, or other t-shirts except club issued may be worn.
- 8) No chewing gum allowed.
- 9) No grading for the karateka will take place unless the karateka's grading, monthly & yearly registration fees have been paid in full and upto date.
- 10) Karateka should at least have done 30 Karate Classes per semester to be allowed to grade and pass the fitness test.
- 11) Grading's will be assessed on the karateka's ability and understanding of the style as well as being able to perform all that is required for that grade.
- 12) **Yearly Membership** fees are payable up until **31 December the same year.**
- 13) **Monthly payments** are payable on the **1st day of each month**, wether it be a public holiday, Saturday or Sunday. Extension will be granted until the **7th of each month.**
- 14) Only EFT Payments will be accepted. **No cash or cheques accepted.**
- 15) The month of December is payable even though the dojo closes early in December. This Fee Counts towards your January fee also.
- 16) **Monthly fees are payable, regardless of classes not attended** due to work, sport or other related activities.
- 17) ***If karateka resigns from Yamaneko-Ryu Karate, there is a one (1) months cancellation and class fees will be payable till the end of the following month karateka has informed Sensei Ivan or Sensei Giovanni of resigning. If karateka does not inform Sensei's of resigning, it is accepted that the karateka is still a member and trainee of Yamaneko-Ryu Karate, and therefore liable for class fees.***
- 18) Any administrative enquiries should be directed to Sensei Giovanni, **BEFORE or AFTER** class, or via electronic mail. The instructor of the class may also be consulted and queries will be directed to Sensei Giovanni via the instructor.
